We can also give you that information if you need to file on a **RUSH** basis. This fee schedule is for a corporation. If you require a different type of entity, please contact us for fees.

If you are preparing and filing the necessary documents with the Delaware Secretary of State and only require registered agent services, our current annual registered agent fee is **\$75\*** and **\$100** for addresses outside of the United States\*.
